What can I claim?

We can recover compensation for your personal injuries. These are called General Damages. We can also claim back your expenses and losses arising as a direct result of your injury. These are called Special Damages.

Special Damages may include:

- Loss of Earnings
- Travel Expenses
- Damaged and/or destroyed personal belongings
- Care and attendance
- Prescription charges and medical expenses

If you have incurred any other expenses we can let you know whether these are recoverable.

If you were involved in a Road Traffic Accident the Special Damages may include:

- Car hire charges
- Repairs to your own vehicle

Will I have to go to court?

The majority of claims are settled with an insurance company without the need for court action. Usually only serious and complex cases result in court hearings.

How long will it take?

This often depends on the nature of your injuries and how quickly you recover. We can give you estimates of timescales as your case proceeds.

You may feel sorry for the other injured party, but do not admit you were to blame until you have taken advice. Do not offer to pay for anything.

Always keep receipts and documents wherever possible.

Ensure that your losses and expenses are kept to a minimum.

If you are receiving DSS Benefits because of your injury, these may be deducted from your compensation.
